



# Online VIPP-SD Training Course January/February/March 2026

Estelle Struis, certified VIPP-SD Trainer at Lorenz Positive Parenting, is hosting an online international training course in the use of the Video-feedback Intervention to promote Positive Parenting and Sensitive Discipline (VIPP-SD). #### **Dates**

Basic Training (7 days): **21, 28 January, 4, 11, 18, 25 February and 4 March 2026**Training days are from **07:00 till 12:00 (UTC+1)**, with two 30-minute breaks.

We are trying to accommodate participants from different time zones, please check your own UTC to see if these times are convenient for you. If not, check out the next opportunity.

<u>Training Supervision (7 meetings)</u>: You will have to plan **6 individual online supervision meetings,** between each home visit (HV), preferably between **March and September 2026**.

Please note that the practice training should start <u>within 6 months</u> after the basic training. The additional **individual assessment meeting** will be planned after HV7.

#### **Costs**

The cost of the VIPP-SD Training Course is **EUR 2.000,-** (VAT exempt, local duties and taxes are at your own expense). <u>This will include:</u>

- the VIPP-SD Manual (including shipping)
- other relevant literature and training materials
- certification and registration at VIPP-SD International
- 7 meetings in the VIPP-SD Basic Training
- 6 supervision sessions in the VIPP-SD Practice Training
- the VIPP-SD Assessment meeting





# **VIPP-SD Basic Training**


The training course will start with the 7-day online VIPP-SD Basic Training. The goal of the basic training is to introduce the participants to the elements of the VIPP-SD Method, thereby increasing their knowledge and understanding of its practical use and its effectiveness. Participants will be taught how to apply the VIPP-SD through guided practice by means of illustrations and exercises. Comprehensive feedback will follow each exercise, led by a certified VIPP-SD Trainer.

## **VIPP-SD Practice Training**

Following the basic training, the participants will start their VIPP-SD Practice Training under supervision. They will have to identify their own VIPP-SD Practice Case with whom they will practice delivering the intervention. Before every home visit (HV) the participants will receive individual VIPP-SD Training Supervision with a certified VIPP-SD Supervisor.

## **VIPP-SD Assessment**

The VIPP-SD Training Course will be completed with an individual VIPP-SD Assessment meeting, discussing the participants competencies, including a self-reflective report and video-feedback on the participant in action.







## Attendance and certification

The participants are expected to attend all sessions of the VIPP-SD Training Course. After completion of the VIPP-SD Basic Training, the VIPP-SD Practice Training and the VIPP-SD Assessment, participants shown to have proficient knowledge and understanding of the method, will be certified and ready to practice. The aim of the course is for participants to:

- Understand the theoretical basis of VIPP and its relation to attachment theory.
- Have familiarized themselves with the principles of VIPP-SD.
- Have had experience of implementing the intervention under supervision of a certified VIPP-SD Supervisor.
- Have a clear idea of how to further develop their VIPP-SD skills.

Certified VIPP-SD Interveners will be registered by VIPP-SD International.

# **Indication of training hours (total 114 hours)**

Basic Training (48 hours): Pre-training video's = 1 hour

Read manual and literature = 12 hours

Online meetings  $7 \times 5$  hours = 35 hours

(of which 7 x 4 hours of teaching = 28 hours)

Practice Case (57 hours): HV 1 (recording only) = 1 hour

HV 2-7:  $6 \times 2 \text{ hours} = 12 \text{ hours}$ 

(travel time not included)

Prepare home visits for intervention (scripts)

= 44 hours, as follows:

- HV 2 & 3: 2 x 8 hours = 16 hours

- HV 4 = 10 hours

- HV 5, 6 & 7: 3 x 6 hours = 18 hours

Training Supervision (6 hours): Individual online sessions  $6 \times 1$  hours = 6 hours

Assessment (3 hour): Preparing for assessment = 2 hours

Assessment meeting = 1 hour





# **Online Training**

This course will be delivered remotely using Zoom. This is very easy and safe to use regardless of your level of IT skill. You will need a desktop PC or laptop with a microphone and camera together with a suitably fast, preferably wired, internet connection. Mobile devices and tablets cannot be used, because they disable certain features used in training. Because of security reasons, you will have to use a Zoom account. Access to the online meetings is restricted to logged-in users only. Also, you will not be able to join from your browser, but only from the Zoom Desktop Client. Please note: Some devices provided by employers may have restrictions in place. Please use this test link (<a href="https://zoom.us/test">https://zoom.us/test</a>) to check your set up. After clicking on 'Join', you will either get a pop-up message asking you to 'open the Zoom app' from your computer (if you already have the Desktop Client), OR you will be able to click on 'Download now', underneath the 'Launch meeting' button. ## **Practice Case**

Following the VIPP-SD Basic Training, the participants will start their VIPP-SD Practice Training with a VIPP-SD Practice Case under supervision. Individual online VIPP-SD Training Supervision will be provided via Zoom with a certified VIPP-SD Supervisor. For the practice case, the participants will need to identify a suitable family as soon as possible before or during the basic training. This could be an acquaintance, a friend (of a friend) for example, with a child between the ages of 1 and 4 years. You will work with one parent/caregiver and one child. Preferably, the family should not be a service user, because you are still learning which makes the effectiveness less optimal. Under certain conditions, a service user could be allowed, please ask for approval first. You will visit the family during 7 home visits. During HV1 you will get acquainted with the parent/caregiver and child and make recordings; this should take no more than 1 hour. The following home visits (HV 2-7) will be intervention sessions in which you will make new recordings and provide feedback on previous videos. Therefore, HV 2-7 will take approximately 1,5 -2 hours each. The home visits may be scheduled about 2-3 weeks apart. The completion of the practice case under training supervision thus takes approximately 3 to 4 months.





## **Equipment**

Working with VIPP-SD means working with video as a professional. For the practice family you need a digital video camera and some (basic) editing equipment (e.g., Adobe premiere pro or Pinnacle Studio). In addition, you will need a USB, DVD player or laptop that can be connected to TV with HDMI cables / or protected external hard drive when a smart tv is available in the home of the family you're working with. And you will need different sets of toys to bring to the family during the home visits. The types of toys will be discussed during the training course.

### Course material and literature

Before the start of the training, you will receive the <u>VIPP-SD manual 3.0 in English</u> via post, and various additional training documents via e-mail.

In preparation of the training, you are required to:

- 1. watch the three pre-training videos links to these are provided in a separate document. (Please note you will be asked to fill out your name and email address before you gain access so you can be identified).
- 2. read the VIPP-SD Manual up to HV3, and
- 3. read the following article:
